

DEFINING CRISIS

A CRISIS is a situation that seriously and immediately threatens one or more of an organization's vital assets: life, property, operations/income, and reputation.

CRISES are characteristically uncommon, unpredictable and sudden, demanding immediate responses in order to save lives, avert secondary damage and restore normal operations.
